Moon is a ready-to-use product that is effective in cut surface applications for killing unwanted trees and preventing undesirable sprouting of cut trees in forest and other non-crop areas including fence rows, roadsides, rights-of-way, and similar areas.

Use Restrictions:

- Not for sale, distribution or use in Nassau and Suffolk Counties in New York State.

Shielded Sprayers

Temperature and Humidity

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

Wind Speed

DO NOT apply at wind speeds greater than 15 mph. Only apply this product if the wind direction favors on-target deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for non-target species, non-target crops) within 250 feet downwind. Drift potential generally increases with wind speed. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

Temperature Inversions

If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. **DO NOT** make applications into areas of temperature inversions or stable atmospheric conditions. Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

Susceptible Plants

DO NOT apply under circumstances where spray drift may occur to food, forage, or other plantings that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, fruit trees, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Application Methods

- **Tree Injection Treatment:** Use 1 milliliter of undiluted **Moon** solution through the bark completely around the tree trunk at intervals of 2 to 3 inches between edges of the injector wounds. Make injections near ground level when using the tree injector or 2 to 4 feet above the ground when using a Hypo-Hatchet injector or similar device. Treatments can be made in any season. Maples must not be treated during the spring sap flow. With some difficult to control species including dogwood, hickory, sugar maple, bigleaf maple, tanoak, and some firs, application to a continuous cut rather than to spaced cuts may be more uniformly effective. **Note:** No Worker Protection Standard worker entry restrictions or worker notification requirements apply when this product is directly injected into agricultural plants.
- **Frill or Girdle Treatment:** Make a single hack girdle or "frill" of overlapping axe cuts through the bark completely around the tree as close to the ground as feasible. Spray or paint the injured surface with undiluted **Moon**, using enough volume to wet treated areas.
- **Stump Treatment:** Spray or paint the cut surfaces of freshly cut stumps and stubs with undiluted **Moon**. The cambium area next to the bark is the most vital area to wet.
