#### 4. FIRST AID MEASURES

##### Description of first aid measures

<b>General advice</b>	Call a poison control center or doctor for treatment advice. Have the product containers or label with you when calling a poison control center or doctor, or going for treatment.

##### Most important symptoms and effects, both acute and delayed

**Symptoms** May cause redness and tearing of the eyes. May cause allergic skin reaction.

##### Indication of any immediate medical attention and special treatment needed

**Note to physicians** Contains petroleum distillate. Vomiting may cause aspiration pneumonia. Thiobencarb is a cholinesterase inhibitor. If signs of cholinesterase inhibition appear, atropine is antidotal. Treat symptomatically.

#### 5. FIRE-FIGHTING MEASURES

##### Suitable extinguishing media

Dry chemical, CO<sub>2</sub>, water spray or regular foam. Move containers from fire area if you can do it without risk. Dike fire-control water for later disposal. Water spray, fog or regular foam.
